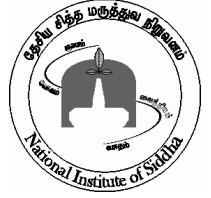

General Conditions:

1. A candidate must not have attained the maximum age prescribed against each post on 01.01.2010 and the upper age limit prescribed above shall be relaxed by five years in the case of persons belonging to SC/ST/Women candidates and blind candidates. However the upper age limit prescribed shall not be applicable to persons in the service of National Institute of Siddha. The experience gained in teaching PG course after obtaining P.G. Qualification in Siddha shall only count as experience gained for each post concerned.
2. The candidates shall not be eligible for appointment if he or she has more than one spouse living.
3. The National Institute of Siddha reserves the right to limit the number of applicants in case large number of applications are received for any or all the posts based on certain factors like screening test, experience in Government / Service
4. All the posts are temporary but likely to continue and the post does not carry the pension liability in National Institute of Siddha.
5. If furnishing of false information and thereby obtaining employment in National Institute of Siddha by any candidate comes to the notice of National Institute of Siddha such individual appointment shall be summarily terminated without any notice/ information.
6. The National Institute of Siddha reserves the right not to fill any or all the posts without assigning any reason. The number of vacancies advertised is only tentative and not conclusive.
7. All the posts carry the allowances as payable to Central Government servants posted in Chennai. Some of the faculty positions carry Non – Practicing Allowance at the rate prescribed by Government of India from time to time.
8. Serving employees should forward their applications only through proper channel. Applications received directly will not be considered and no action will be taken on the advanced copy of the application forwarded by the applicants including calling for the interview. Wherever the space given in the application is insufficient separate sheet may be added to the application duly furnishing the information required.

9. The completed application should be accompanied with certified true copies of the education qualification and experience, etc., and in no circumstances the original certificates should be enclosed and NIS will not take responsibility for the loss of such original certificates if any.
10. Filling up of any or all the posts will be at the discretion of competent authority of NIS and no interim correspondence will be allowed in this regard. Canvassing in any form will be viewed seriously and such application shall be summarily rejected treating the same as disqualified.
